2. Invoicing of material-Firm shall raise the Invoice for liquid oxygen gas in cubic meters. The quantity of liquid oxygen delivered shall be measured in terms of cubic merers determined the residual weight from the initial weight of the VITT(Vaccum insulated transport tanker). Conversion factor:-1 Kgs. of liquid oxygen=0.77 CuM of Oxygen gas equivalent at 27oC and at 1 atmosphere.
3. Fixed Facility charges(per Portacryo)-Firm may include in the basic price of liquid oxygen.4. Connection will be done by the supplier, with the existing pipeline of oxygen gas in necessary equipments & fittings will be arranged by Rlys.5. Transportation charges of Portcyro tanks-Borne by the supplier.6. After completion of the supply order, supplier will take back their portocryo tank unit on their account.7. The safety of the performance of the portocryo tank and its testing etc. is the responsibility of supplier. No claim in this regard will be acceptable.8.
