 - i. One time Registration fee- Rs. 10,000/- refundable whenever buyer will opt for cancellation of their registration. **It shall be noted that buyers shall only be able to participate in e-auction with their registration on www.ireps.gov.in.**
 - ii. Bank account in any branch of State Bank of India with net banking facilities. All net banking account with SBI shall only be acceptable and no other bank account will be acceptable.
 - iii. A digital certificate (class III- B).
 - iv. A valid email address of buyer.
 - v. Affidavit in prescribed format available on website www.ireps.gov.in.
4. Auction Catalogue will be made available at website www.ireps.gov.in at least seven days before the E-auction.
5. No manual bid shall be considered against lots kept in e-auction.
6. As per public notice published on 10.04.2012, training for buyers/bidders have already been conducted on 13.04.2012 on WRS/KOTA. Bidders are advised to get themselves registered at website www.ireps.gov.in at the earliest. Additional training if considered necessary shall be conducted between 21st May and 25th May'12 at CRWS/BPL. Following officers can be contacted for training and any other clarification.
7. The e-auction above scheduled are in addition to manual auction already notified/published. Manual auctions shall also be continued till further notice.
