Applications are invited from the Citizens of India for recruitment against Scouts & Guides Quota for the year 2012-13 for filling up **02 (TWO) posts** each in Group D category, Scale Gr Rs.-5200-20200 Grade Pay Rs-1800; for **Jabalpur, Bhopal & Kota Divisions of W.C.Rly.** Candidate fulfilling the following conditions may submit their application in the Pro-forma enclosed as Annexure "A"

- MINIMUM EDUCATIONAL QUALIFICATION AND AGE:**
10th pass / ITI / equivalent from recognised board.
- AGE LIMIT:** The age limit 18-33 years as on 01-01-2013.
The lower and upper age limit indicated will be reckoned as on 01-01-2013. The upper age limit is relaxable as under subject to submission of requisite certificate.
 - By 5 years for SC/ST Candidates.
 - By 3 years for OBC Candidates.
- SCOUTING / GUIDING QUALIFICATIONS:**
 - A President's Scout/Guide/Ranger/Rover OR Himalayan Wood Badge Holder OR A Pre-HWB trained Scout leader/Advanced Trained Guide Leader / Captain
 - Should have been an active member of a Scouts Organization for at least 3 years in the recent past and should continue to be active member.
 - Should have attended at least one event at National level and one or two events at State level. OR
 - Should have a good record of participation in Scouts / Guide activities at unit/District Level.

Note: The certificate of Scout / Guide should be issued prior to the closing date of this notification. The Participation certification will not be considered as eligibility for 3 (a) above.

- PROCESSING FEE:**
The processing fee for recruitment against Scouts & Guides Quota will be **Rs. 40/-**. Date of issuing of IPO/Bank Draft should not be before the date of issue of this Employment Notice. SC/ST candidates, Women, Minorities, Economically Backward Class and Ex. Servicemen are exempted from payment of examination fee. Postal Order/Bank Draft should be in the name of
 - Sr Divisional Finance Manager, Jabalpur** payable at Jabalpur for Jabalpur Division.
 - Sr Divisional Finance Manager, Bhopal** payable at Bhopal for Bhopal Division.
 - Sr Divisional Finance Manager, Kota** payable at Kota for Kota Division.

Econ. Backward Class means the candidate whose family income is less than Rs 50,000/ per annum. The income certificate issued by DM / SDM / Tahsildar is required.

Applications should be sent by ordinary post in a closed envelope or to be dropped in the box provided for the purpose in Recruitment Section of "P" Deptt. upto 17.00 hours **at above address mentioned at 5.** The last date for receipt of application is **22.02.2013 upto 17.00 hrs.** On the top of the envelope "APPLICATION FOR RECRUITMENT AGAINST SCOUTS AND GUIDES QUOTA" & "EMPLOYMENT NOTICE NO. 1/SQ/Scout & Guide /2012-13 / Division..... /JBP / BPL / KTT" should be super-scribed. **No application will be accepted after the closing date for whatever reason and any enclosure received separately after the receipt of application will not be entertained.**

(c) Self Attested copy of Caste Certificate in the case of SC/ST/OBC candidates and Current Creamy Layer Certificate in case of OBC candidate issued by the competent authority. (d) Two recent passport size photographs duly signed are to be attached with the application. Photo pasted on the application should be self attested.

8. PROCEDURE FOR RECRUITMENT:
The candidates, who apply in response to this notification and are found eligible for consideration, will be subjected to written test followed by Interview / personality tests for those who qualified for viva-voce over and above the minimum prescribed eligibility criteria. The **Written test** will be held on **16.03.2013(Saturday)** in **Divisional Railway Manager's office of respective divisions or at venue as advised by the respective divisions** and the **Interview/ Viva Voce test** will be held on same day. The decision of West Central Railway in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection, incomplete applications will be rejected and no further correspondence in this regard will be entertained. No separate communication will be sent to the candidate in this regard. List of Eligible candidates will be uploaded in the website www.wcr.indianrailways.gov.in.

Thinking day; Progressive training of Scouts/Guides/Rovers/Rangers; Pioneering; Handicrafts; Indian Railway Jamborette; National Jamboree; Jamboree on the Air.

The decision of West Central Railway in all matters relating of eligibility, acceptance or rejection of application, or rejection of the application, penalty for false application mode of selection, allotment of posts to selected candidate will be final and binding on the candidates.

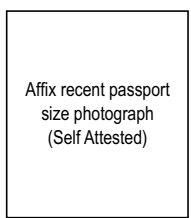
