1. As per rules, 3 post for SC, 1post for ST and 5 posts for OBC candidates are reserved. Remaining 9 posts are unreserved.

2.Candidates up to three times the number of vacancies will be kept in waiting list and vacancies occurring in near future will also be filled up by them..

3. The offer of engagement to the selected candidates shall be issued subject to the availability of the vacancy as per requirement in hospitals/Health Units located at different station on as is where is basis. Any subsequent request for change of station shall not be entertained. However, administration has right to change the place of posting as per administrative needs.

4. The CMP specialist doctor so selected shall also have to carry out general duties as and when required by railway administration besides their specialty work.

5. In case of non – availability of prescribed speciality, posts may be filled up by candidates having alternate similar speciality or General Duty doctor. Decision of selection committee will be final.

6. The places of notified vacancies may be changed as per requirement.

Eligibility Conditions:

1.	Age limit:	<p>(i) Less than 50 years</p> <p>(ii) Relaxation in maximum age limit:</p> <p>5 years in case of SC / ST candidates.</p> <p>3 years in case of OBC candidates.</p> <p>(iii) Retired Railway Doctors may also be engaged against existing regular vacancies for a period of one year or the regular incumbent joins or till they attain age of 65 years whichever is earliest.</p> <p>The age will be reckoned as on 01.10.2013</p>

2.	Educational Qualification:	(i) <i>For General Duty Doctors</i> : MBBS degree (With complete internship) from any university / institution recognized by Indian Medical Council. (ii) <i>For Specialist Doctors</i> : Post Graduate degree in the subject concerned from any university / institution recognized by Indian Medical Council.
3.	Experience:	Preference will be given to experienced candidate.
4.	Period of Engagement:	As per requirement initially contract will be made for maximum period of one year. After every one – year period a fresh contract can be made up to total period of eight years subject to their performance.
5.	Monthly Remuneration	(i) For notified/alternate similar Specialist Doctors – Rs. 46,800/- (ii) <i>For General Duty Doctors</i> – Rs. 39,400/- (iii) <i>For Retired Railway Doctors</i> - Rs. 46,000 subject to the condition that remuneration + pension drawn by them should not exceed the last pay drawn as per instructions given in Railway Board's letter No. 2008/E(GR)II/1/1 dated 16-07-2012.
6.	No objection certificate:	Doctors who are working under central government, state government or in public sector undertaking should bring with them No Objection Certificate from their employer / organization.
7.	Caste Certificate	Candidates belonging to reserved community should bring with them original caste certificate.
8.	Private Practice	Private practice will not be permitted during the tenure of the contract.
9.	Termination of service	During the period of contract, medical practitioners are free to terminate the contract on the ground of his / her career or any other reason by giving 15 days prior notice. Without assigning any reason, Railway Administration can also terminate the contract on giving them 15 days prior notice. In case any medical practitioner is found physically or mentally invalid or incapacitated the contract can be terminated.

The candidates who fulfill above terms and conditions and having requisite qualification should present on the date, time and venue with duly filled application form as per format available on website with their original certificates (along with one set of attested photo copy of each certificate by Two

Gaezttd officers of Central Govt./State Govt.) of date of birth, educational qualification, experience, caste (in case of candidates belonging to reserved community), registration and two passport size photographs.No TA/DA or free railway pass is admissible to any candidate for appearing in walk-in-interview.
