


**1.0 SCOPE OF SUPPLY**

The scope covers the technical detail of material, terms & condition and inspection for supply of set of seat and back rest of GS coaches at CRWS, Bhopal.

**2.0 GENERAL CONDITIONS**

- 2.1 Material manufacturing, supply and transport are the whole responsibility of supplier.
- 2.2 Unloading and unpacking of the material at nominated place will be done by Railway and same will be witness by the firm representative for confirmation of any transportation damages . Transport damage will be jointly recorded by firm representative and store representative. If any, transport damage noticed same can be rectified by the firm with the approval of Dy. CMM / CRWS/ Bhopal at their own cost.
- 2.3 Firm has to ensure that all the fittings are injury free.
- 2.4 Agreement has to be given in writing on non - judicial stamp paper of Rs. 100 that if there is any customer claim for injury due to material or bad workmanship of supplier then the firm will bear the compensation, if compensation is claimed within two years after turning out the coach.
- 2.5 The material used for manufacturing of seat and berths will be as per latest RDSO specification. Details of Drawing & material given in Clause 3.0 & Clause 4.0.
- 2.6 Supplier will strictly follow the safety rules as per factory act inside the workshop during supply.
- 2.7 The supplier shall be responsible for ensuring safety of his staff while supplying seat and berths within the Railway premises. In case of accident/causality during supply, the Railway will not be responsible for any compensation.
- 2.8 The supplier shall not take any advantage of any misinterpretation of the conditions due to typing or any other error and if is in doubt, shall bring it to the notice of the Chief Workshop Manager, CRWS, Bhopal without delay. His decision will be final.
- 2.9 Rejected material should be replaced by the firm at their own cost .
- 2.10 No claim whatsoever will be given to the supplier in any circumstances.
- 2.11 Material for making the seats and berths shall be procured from the approved sources advised by RDSO as valid on date of opening of tender. Suppliers are advised to refer the latest RDSO vendor list for the current approved source of supply.
