INSTRUCTIONS

- This form may be obtained, by hand on paying Rs.2500/- or by post by sending a
 Demand Draft of Rs.2500/-. If this form is downloaded from
 www.wcr.indianrailways.gov.in it must be sent to this office with a Demand Draft of Rs.
 2,500/-. The Demand Draft should be in favour of FA&CAO, West Central Railway,
 Jabalpur.
- 2. In the space given on the top of the form, indicate the brand and category of product for which short-listing for supplies to licensee units is sought. Each form is valid for one category of product only.
- 3. Maximum 5 products of a category will be considered for approval under a single application. However, a company can submit multiple applications (with specified license fees) for shortlisting of more products.
- 4. As per Railway Board instructions at Jabalpur, Katni, Rewa stations (during entire year) & at Satna station (during non peak season only) only Rail Neer PDW will be sold hence the other brand of PDW will not be sold at these stations. Also in future if any other station is included for mandatory sale of Rail Neer then the other brand of PDW will not be permitted for sale at that station and no refund will be granted in this regard.
- 5. This form is available free for Small Scale Industries Unit applicants, registered with National Small Industries Corporation.
- 6. Information desired in all fields are essential, applicants must comply with the corresponding query. If the space provided is not sufficient the applicant may attach extra sheet(s). Applicants should fill all fields, if the field is not applicable, write 'Not Applicable'.
- 7. All the details must be given along with required supporting documents duly Notarized or attested by a Gazetted Officer.
- 8. West Central Railway reserves the right to reject any application at any point of time without assigning any reason.
- 9. West Central Railway's decision on Short-listing of applicants shall be final and binding.
- 10. The Short-listing will be valid for one year.
- 11. Affidavit :- The applicant have to submit an Affidavit of proprietor/partner/authorized person that :-
- (i) The Firm has not been banned/blacklisted/debarred by IRCTC, any other Railway, Ministry of Railways or any other Government Department.
- (ii) The fact/statements mentioned in the Application and Documents submitted with the Application are genuine and true. If Railway Administration finds any fact/ statement/documents fake or wrong, at any point of time my application may be rejected and suitable penalty including termination of registration, black listing, banning and debarring may be imposed.

The affidavit should be submitted in original on Rs 500/- non judicial stamp paper duly notarized.

- 12. A non refundable fee of Rs. One Lakh (Rs. 1,00,000/-) along with applicable GST rate (please see NOTE at page 3), for each application form separately, has to be deposited along with the application form in the form of Demand Draft drawn in favour of FA & CAO, WCR, Jabalpur. The fee amount shall be refunded only to those applicants whose products are not approved.
- 13. The MRP/gms. of the product should not be higher than the MRP/gms. of same product in the local market under any condition and product should not be supplied with labels like "specially packed for Railways".
- 14. West Central Railway reserves the right to collect samples of the products and getting them examined in the appropriate laboratory and also inspect the production facilities, as and when it deems necessary.
- 15. In case the validity of any of the FSSAI/BIS certificate expires during the shortlisting process or during the currency of the permission period, the company should submit the renewed/new certificate issued by the concerned authority within a month of its expiry. If the renewed document is not produced within the specified period the license fees of the remaining months will be forfeited and approval for the remaining period will be withdrawn with immediate effect after the expiry of one month grace period.
- 16. Applications are advised to submit all the required documents with their applications. The applications will be shortlisted within 2 months from last date of submission of application after which no further application will be entertained.

NOTE

GST rate as on date is 18%, hence the amount of GST will be 18,000 (18% of 1.00 lakh).
