## **EXPRESSION OF INTEREST FOR EMPANELMENT OF DESIGN & PROOF CONSULTANTS FOR RAILWAY BRIDGES & STRUCTURES.**

### **1. INTRODUCTION**

- 1.1 West central Railway construction organization intends to shortlist Detailed Design & Proof check consultants for preparing a standard panel of approved consultants of repute to engage them for specialized design job on need basis.
- 1.2 Consultants will be short-listed for following categories of works: Structural design and proof checking of railway bridges, FOBs/ROBs, Tunnels etc. of:
  - (i) Steel/Composite (Steel+Concrete) Superstructure
  - (ii) PSC/RCC Super Structure
  - (iii) Substructure/Foundation of any type
- 1.3 The panel of respective category shall normally remain valid for 2 years from the date of empanelment extendable up to one year at discretion of Railways if felt necessary. Addition/deletion in the list can be done by railways once in a year. Deletion of consultant from panel shall be done on the basis of bad performance report from the client.
- 1.4 Consultants shortlisted for pre-qualification may not necessarily be hired by construction organization of west central Railway assigning job to any of shortlisted consultants will be purely on discretion of Railways. Mere empanelment does not guarantee job to any consultant neither Railway is bound to do so.
- 1.5 Interested consultants may apply for pre-qualification individually or as joint ventures, partnerships or consortia (groups). However, they will not be permitted to tender for the same contract as an individual or individual firm and at the same time as part of a joint venture, partnership or consortium. Also any firm can participate or become member of only one consortium/joint venture/partnership.
- 1.6 Applicants for pre-qualification should note that this Pre-Qualification Enquiry and Questionnaire is intended to provide consultants with preliminary information. The information contained herein shall not in anyway be constructed as binding on Construction Organization of West Central Railway.
- 1.7 Applicants are advised that selection of consultants shall be entirely at the discretion of

Construction organization of West Central Railways. Applicants are deemed to have understood and agreed that no explanation or justification of any aspect of the pre-qualification process will be given and that Railway's pre-qualification decisions are without any right of appeal whatsoever.

- 1.8 All costs incurred by an applicant for pre-qualification shall be borne by the applicant, construction organization of west central Railway, are entirely without liability for such costs on other parties.
- 1.9 Railway reserves the right not to proceed with the pre-qualification procedure at any time without notice or liability.
- 1.10 All documents and other information's supplied by Railways or submitted by an applicant shall remain or become the property of West central Railways. Applicants are to treat all information as strictly confidential. Construction Organization of West Central Railways will not return any pre-qualification submission except the original documents, if any.
- 1.11 Construction organization of West Central Railway will notify successful applicants of the result of pre-qualification. However, pre-qualification of applicant does not make binding on Construction Organization of West central Railways that they must be awarded a contract. They will have to participate in tenders and same will be decided on its merits.
- 1.12 Construction Organization of West central railway will scrutinize the designs/drawing presented by consultant and will give the final approval.
- 1.13 Same consultant shall not be the proof checker of their own design.
- 1.14 Foreign firm shall be considered for empanelment only when the firm has representative office in India.

1.15 The Tenderer/Firm should be registered with Municipal Corporation/State Govt./PSU for Civil Engineering Design & Drawing work.

## **2.0 SCOPE OF WORK**

### **2.1 The Scope of Work for the Design Consultants :**

- 2.1.1 Conduct Design Alternatives on the conceptual design/GAD using principles of cost effective design.
- 2.1.2 Prepare a design basis note prior to start the actual design as per prevailing IRS/IS/IRC Codes.
- 2.1.2 Wherever codal provisions are not available consultant shall use sound engineering practices and provide the complete logic for using the practice.
- 2.1.3 Perform detailed designs of structures (Superstructure, substructure, foundation, expansion joints, bearing & Seismic restrainers etc).as per scope of work given in work orders.
- 2.1.4 Prepare the detailed design document which can be easily understood by the approving authority i.e. Construction organization of West Central Railway.
- 2.1.5 Incorporate changes advised by proof consultant/construction organization of West Central Railway design cell.
- 2.1.6 Plan, design, detail, control, co-ordinate, and execute the design phase of the Works for production of drawings, documents and reports to meet the key schedule date included in the Agreement and as directed by Railway.
- 2.1.7 Attend all meetings and prepare, distribute and maintain all meeting minutes, reports, notes, correspondence and other documents of whatever nature required during the course of the work.
- 2.1.8 Proof checking of designs and drawings shall be done by proof consultant selected by Railway.
- 2.1.9 Engage a qualified design team for engineering services during the construction stage to review contractor's bar bending schedules, shop and working drawings for the Works for compliance with the design requirements and contract documents; to prepare supplement reports, calculations, recommendations, etc. or modify existing drawings as necessary to incorporate site requirements and unforeseen conditions.
- 2.1.10 Providing solutions to the various problems during construction stage as raised by the field engineers.
- 2.1.11 The design calculations to be submitted to the Railway for approval shall be in any of the following format: -
  - 1 Design done manually supported by the step by step detailed structural calculations.
  - 2 Alternatively design may be submitted in the form of computer input file/data along with calculations accompanied with soft copy.

2.1.12 Design documents shall be submitted to Railways along with checklist (can be modified if required) placed as **Annexure- 11**

**Special Conditions:**

1. Standard of loading to which designs are to be proof checked is 25 ton axle load unless otherwise specified by Railways.
2. The Design consultant shall take utmost care to provide economical design for various components of bridge duly keeping in view.
  - 2.1 The requirement as per various codes and standard practices.
  - 2.2 Feasibility of construction under traffic where ever required.
  - 2.3 Maintainability sufficiently in detail to the satisfaction of Railways.
3. In case of any difference of opinion on any technical or other aspect relating to work between design and proof consultant the decision of Railways shall be final and binding on the consultant.
4. All designs & drawings being carried out under this contract shall be property of West Central Railway who shall have exclusive right.
5. Approval of initial design note of Design consultant suggesting modification and implementation of corrections wherever required.
6. All documents and drawings should be signed by Design consultant.
7. In event of any dispute or difference relating to interpretation and application of provisions of this contract, such disputes shall be mutually discussed and settled with Dy.CE(C). In case no settlement is arrived at, the decision of Chief Engineer (Construction), West Central Railway shall be final and binding.

**2.2 The Scope of Work for the Proof Consultants:**

- 2.2.1 Construction organization of West central Railway will provide GAD and structural drawings submitted by design consultant. Proof consultant will be required to thoroughly examine the drawings for following:-
  - 1.1 Compliance with approved GAD.
  - 1.2 Provisions of latest IRS/IS/IRC codes guidelines.
  - 1.3 Geotechnical investigation report.
  - 1.4 Workability/feasibility, safety and economy of design proposed by design consultant.
- 2.2.2 In case of any discrepancies the drawings should be returned with detailed observations supported with rules/clauses violated etc.
- 2.2.3 Proof consultant shall submit their independent design calculations to support their recommendations.
- 2.2.4 Proof consultant will forward their recommendations to Construction organization of West Central Railways along with checklist(tentative can be modified if required). Placed at **Annexure-12**
- 2.2.5 In case of any difference of opinion on any technical or other aspect relating to work between design and proof consultant the decision of railway authority shall be final and binding on the consultant.

**Special Conditions:**

1. Standard of loading to which designs are to be proof checked is 25 ton axle load unless otherwise specified by Railways.
2. In case of any difference of opinion on any technical or other aspect relating to work between design and proof consultant the decision of Railways shall be final and binding on the consultant.
3. Same consultant shall not be the proof checker for their own design.
4. Proof consultant will check the design independently on the basis of GAD and structural drawing submitted by the design consultant and provide the detailed calculation sheet and offer his comments on the quality of the design submitted by design consultant and also offer the comments on the economy, safety of design and suitability of design. Proof consultant will communicate only with the concerned field Dy.CE/C. Proof consultant will not directly enter into any correspondence with Design consultant. After the suggested modifications/corrections agreed by concerned field Dy.CE/C or his representative the same will be communicated to Designer by Railways. The corrected/modified design & drawings resubmitted by designer will again to be scrutinized by proof consultant before making final recommendation for their approval by Railways
5. All documents and drawings should be signed by proof consultant.
6. After satisfying the various codal provisions/specification/Railways guidelines, requirements and necessary correction/modification suggested(if any) are incorporated in design; the proof check tenderer will recommend the approval of design & drawings with following certificate: -
  - a. "Contents have been checked from page No.\_\_\_\_to Page No.\_\_\_\_ . The Design is safe, sound, economical & fit for execution.
  - b. Loadings taken for designs are as per latest relevant IRS, IS & IRC, Codes and other Railways specifications.
  - c. In all members stresses are within permissible limits specified by relevant codes.
  - d. Detailed structural drawings are in confirmation with design & approved GAD".
7. In event of any dispute or difference relating to interpretation and application of provisions of this contract, such disputes shall be mutually discussed and settled with Dy.CE(C). In case no settlement is arrived at, the decision of Chief Engineer (Construction), West Central Railway shall be final and binding.

**Schedule of Payments for Design & Proof consultants: -**

Payment shall be made for the work done against work orders issued from time to time.



### 3.0 EVALUATION CRITERIA

#### 3.1 Introduction

The Evaluation Criteria is prepared for evaluating the Applicants for their suitability to perform the Detailed Design/Proof checking for structural design of railway bridges, Road over Bridges/Foot over Bridges etc.

The Points Scored will be based on score table.

Minimum of 60% score of the aggregate will be “Qualifying” score for Empanelment, subjected to other mandatory conditions are fulfilled.

#### 3.2. Basis for Weightage

The weighting has been determined by the importance of the Topic. The weighting is graded between 5 and 25, depending on the relative importance of the assessment topic.

### 3.3. Basis for Awarding Points

The purpose of the points system is to be able to put the Applicants into a “pecking order” of capability. Therefore whilst there may be some subjective consideration as to what constitutes the award of points, as much as possible criteria for awarding points has been laid down based the response of the Applicant to the Questionnaire. It must be appreciated that the answer to some Topics are a Yes or No answer, with only 3 points or 0 points awarded is:

### 3.4 Evaluation by Railways:-

Railway’s Evaluation Team will go through the document of each applicant for respective category and prepare the evaluation sheet and award the scores. The team will use their judgment in case of subjective aspects while awarding the scores.
