In reference to the letter cited under ref. 2 above, Notification was issued for Selection of AEN Group B (Level 8), GP- 4800- under 30% LDCE quota.

As per instructions issued vide Railway Board's letter under Ref. 1 & 3, following instructions are amended/added in the aforesaid notification -

### **Scheme of Examination-**

1. In terms of Railway Boards L. No. E(GP)2022/2/4 dated 28.06.2022, Board has decided to introduced Centralized Computer Based Objective Type examination.
2. LDCE will be one stage only and will comprise of only 1 Paper with the following set up:
  - (a) single paper of 150 marks comprising 100% Objective type Multiple Choice Questions with following distribution of marks.

(a) (i) Technical (Professional) subject	:	80 marks
(a) (ii) General Knowledge including optional Questions of 15 marks on Official language Policy & Rules	:	40 marks
(a) (iii) Establishment & Financial Rules	:	30 marks
  - (b) **Qualifying Marks-** : **90**
  - (c) **Duration-** : **3 Hours**
3. Question paper will have 175 questions out of which 150 questions are to be attempted.
4. 1 mark will be allotted for every correct answer. There shall be negative marking for incorrect answers and 1/3<sup>rd</sup> of Marks allotted for each question will be deducted for every wrong answer.
5. **Syllabus-** Syllabus for LDCEs for Organised services has already been prescribed by Board. However, as it is based on old pattern when there were two Papers- Paper-I and Paper-II in the LDCEs, the Centralised CBT shall be held from the said syllabus after amalgamating the topics prescribed in Paper-I and Paper-II of respective syllabi.

6. Optional Questions on Official Language policy and Official Language Rules in the LDCEs shall be included in terms of provision contained in Para 204.3 of IREM Vol. I.
7. CBT for AEN-30% LDCE exam will be held on the same day across Indian Railways. Thereafter no request for a supplementary exam shall be entertained in any condition.
8. Other instructions of Notification will be same as earlier.
9. If any employee who did not apply earlier but, is now interested in applying against aforesaid notification in light of amendment of above instructions, he/she may submit his/her applications by dt. 18.07.2022. Those employees who have applied earlier are not required to re-submit their applications.
10. HQ/Divisions/Units are advised to send applications of only eligible employees to HQ after scrutiny of applications.
11. In case, any employee is on ex-cadre/deputation etc. may also be informed.
12. For sending eligible applications to HQ, important dates are given as under -

Training of SC/ST employees for the written test will be conducted by the Division/HQ (if required)	<b>From 03.08.2022 for 15 working days -- to be conducted by department concerned.</b>

13. Date of written examination will be decided by Board and informed accordingly.
