1. The selected candidates should note that the result is **provisional** and does not confer on them any right to appointment on Railway. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.

2. The provisional panel is based on candidate's merit position, choice, community, availability of Post and medical fitness.
3. The offer of appointment shall be sent separately by the respective Units/Divisions where the candidates are allotted. The offer of appointment should be issued after verification as per extant rules.
4. The cases where the name of candidates appears differently in various certificates may be examined thoroughly. The certificates of educational qualification, Date of Birth, Caste certificates, PwBD certificates, CCAA certificates, EWS certificates, etc. submitted by candidates may be verified before issue of offer of Appointment.
5. SC/ST/OBC/EWS/PwBD candidates who have yet not submitted caste/EWS/PwBD certificate in prescribed Central Government format as per notification with proper issuing authority are advised to submit the same when called for appointment.
6. Those serving candidates in any Central/State Government Department (including those undergoing induction training/probation) including Railways or Public sector undertakings, who have not submitted No Objection Certificate (NOC) for serving employee, they should submit No Objection Certificate (NOC) at the time of appointment.
7. Those candidates who have not submitted requisite documents (Affidavit, EBC, NOC, etc.) in response to RRC notice are required to submit the same at the time of appointment.
8. The above mentioned candidates shall be considered for appointment in Railway, subject to:-
  - a) Vacancies are available,
  - b) He/she will produce original certificates of educational qualification, age ,community etc. in support of his eligibility as per the notification,
  - c) Genuineness of the certificates submitted by him,
  - d) Completion of requisite administrative formalities/procedures,
  - e) His/her photograph, signature, handwriting and other details in his/her application match before appointment and at the time of actual joining of working post,
  - f) They are not appearing in the debarred lists issued by any RRB/RRCs.
9. This is a provisional part panel and Roll Numbers of some candidates have not been declared due to Non-qualifying the Medical examination in requisite medical standards, being temporary unfit and whose cases/files are being referred to Finger Print Examiner (FPE)/GEQD for expert opinion and shall be declared later if found fit/authentic and fulfillment of all laid down requirements and other reasons.
