
**Sub: Publishing Draft Voters List (DVL)- Secret Ballot Election for recognition of Trade Unions.**

**Ref: Board's letter of even no. dated: 26.07.2024**

Vide Board's letter referred above, the guidelines and timeline for issuing Draft Voter List was conveyed, as per which the last date for uploading the DVL on official website, was shown as 09.08.2024.

2. Since it would be prudent to keep the voter list in draft stage till notification of the elections, the timeline given vide above referred letter is now being withdrawn. Railways and concerned PUs are required to prepare the DVL with the cut-off date given and diligently record all changes regarding voters under their jurisdictions, that is inflows and outflows, so that as and when the final voter list is to be notified the same can be uploaded by incorporating the changes recorded.

3. All Presiding officers/ Assistant Presiding Officers, as defined in the modalities for the elections held in 2013 and shown in the modalities issued in 2019, may upload the DVL and call for objection if any, and take remedial measure for rectifying the same. As and when instructions are given from SBEC, the exercise of notifying the revised DVL incorporating the changes may be published, for election purpose.
