**Subject: Corrigendum No.3 to 'Final Modalities' issued vide No.2024/SBEC-III/Elections dated 09.09.2024 for Secret Ballot Elections-III.**

In terms of provisions of Section 22 of Final Modalities, the SBEC has approved modifications in the 'Final Modalities' by inserting the following subsection 16.22.1, beneath section 16.22, regarding Polling parties, .

"16.22.1 The Polling Party should be absolutely impartial and non-partisan in its functioning, without feeling fear or favour towards any contesting TU. In order to ensure this, the Polling Party for each Polling Booth should be constituted by nominating officials from different offices as far as possible.

No Controlling Supervisor/Officer may be assigned the role of Polling Officer at a Polling Booth where majority of the voters are direct subordinates to her/him. For example, on open line ZR, an SSE/PWAY may be nominated as Polling Officer for a booth where primarily voters from departments other than Civil Engineering department are listed for voting. Similarly, for Polling Booths having Trackmaintainers primarily, the Polling Officer may be from S&T/Electrical/other department. Likewise, in Workshops/Stores Depots and Production Units the Section/Shop incharges should be so rotated that they are deployed as Polling Officer in a section/shop, which they do not control directly."
