In reference to the above, it has been informed that secret Ballot Elections for verification/ recognitions of trade unions on Zonal Railways including Metro Railway, CLW/Chittranjan and RCF/Kapurthala is scheduled for 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> December, 2024.

In view of above, it is advised that the following arrangements may be ensured in consultation with State Governments:-

1. Co-ordination with State Governments to ensure law and order arrangements.
2. Assistance of Home guards wherever required.
3. Security at election booths, Ballot Boxes storage places, during transportation of Ballot Boxes and at counting places.
4. Help in identifying sensitive booths.

Necessary actions may be taken in consultation with concerned authorities.
