 - Handling of voters covered under Right to Persons with Disabilities viii. Act,2016 (Section 13 of Final Modalities).

- Instructions regarding mobiles by Polling Personnel, Voters and Polling ix. Agents. (Section 16.17.11 and 16.17.12 of Final Modalities).
 - Knowledge regarding stationery to be used in the elections. X.
- All procedures related to elections required to be followed at the level of xi. Polling Officers, Presiding Officers and Returning Officers.
- All formats to be filled up by Polling Officers & other authorities. xii.
- Postal Ballot System Training to be given to concerned officials under xiii. Presiding Officer/Returning Officer.
