- 1. Drug License No. & its Validity.
- 2. Authorization letter from the manufacturers.
- 3. The average annual turnover of the firm for the previous three years should be Rs. 5 Crores and above for manufacturers and Rs. 50 lakhs and above for marketing firms/ agencies (distributors). As per Ministry of micro, small and medium Enterprises (MSME) letter criterion for Turnover eligibility criteria may be relaxed for **MSME**.
- 4. The firm must not have been convicted and a case should not be pending under the drugs & Cosmetic Act & Rules.
- 5. Rs. 5000/- need to be deposited by the firm as Registration fee for registering the firm for a period of 3 years that will be taken only after receipt of written confirmation from PCMD's office. This payment is being done through miscellaneous e-Receipt System (MERS Portal).

In case of doubt, PCMD or its authorized representative shall have the right to inspect the manufacturing premises. All the registered firms (Distributers/Manufacturers) are advised to register themselves with IREPS by obtaining Class III Digital signature so as to participate in E-procurement.
