**3. EDUCATIONAL/PROFESSIONAL QUALIFICATIONS:**

(i) The candidate should be a minimum MBBS pass degree from an institute recognized by the Indian Medical Council and with registration in Indian Medical Council, or with a valied registration certificate of any of the State Medical Council of India after completion of one year of compulsory,rotator Internship.No other certificate will be accepted.Higher qualification,if any,will be given due preference.

(ii) For Part time Lady Doctor MBBS passed, must have three years working experience or be a post graduate (MD or MS) and with Registration in Indian Medical Council or in possession of valid Registration Certificate of anyof the State Medical Councils of India after completion of one year compulsory Rotatory Internship.

(iii) Doctors serving under State/Central Govt./Public Sector undertaking etc.may apply with 'NOC' from the respective orgizations.

(iv) The candidate should be a minimum MBBS pass degree from an institute recognized by the Indian Medical Council and with registration in Indian Medical Council, or with a valied registration certificate of any of the State Medical Council of India after completion of one year of compulsory,rotator Internship.No other certificate will be accepted.Higher qualification,if any,will be given due preference.

(v) Doctors while applying should indicate past service renderd, if any,including the period of contract put in by them on all over Indian Railway

**4. AGE LIMIT :**

(i) Not exceeding 53 years of age as on date of notification. However age relaxation is admissible for 5 years to SC/ST Category candidates and 3 years for OBC category candidates. The maximum age limit is 65 Years or 12 terms whichever is earlier and each term of engagement shall not exceed more than one year.

- (ii) For retired Railway Doctors, retired government Medical Doctors of State governments and Central Government, age to be considered is 65 years as on date of notification. The number of annual term of Engagement of retired government Doctors engaged as Contract Medical Practitioner is SEVEN Subject to attaining the age limit of 67 years, whichever is earlier and each term of engagement shall not exceed more than one year.

**4. Remuneration:**

- (i) Part Time Lady Doctor for Four hours per day, 06 day's in a week Rs.36,900/-(including HRA & Transport Allowance). Daily rate of deduction from the fee for absence, in excess of eligibility may be Rs.1,230/-per day.
- (ii) For Medical Practitioner on Contract basis- Full Time
- And
- (iii) For Retired Railway/Government Doctors engaged as CMP-Full Time (Subject to the condition that remuneration plus pension shall not exceed the last pay drawn).
- (iv) Monthly remuneration is Rs.95,000/- (including HRA & Transport Allowance) for Full Time General Duty Medical Officer. Daily rate of deduction from the fee for absence, in excess of eligibility may be Rs.3,167/- per day.
- (iii) If Railway accommodation is provided, The remuneration specified above includes the following amount of Rs.10,098/-( CMP-GDMO) as House Rent Allowance and license fee of the accommodation so provided will be deducted from the monthly fee admissible to the concerned Medical Practitioners.

**3. Other Terms & conditions**

- (i) Selected candidates will be subjected to medical examination and only medically fit candidates will be engaged as CMP. At the time of entering into the contract, the CMP shall produce certificate of his/her Character and antecedents certified by Gazetted Officers of the Central/State Govt.
- (ii) The full time Contract Medical Practitioner who enters contract with the Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract.
- (iii) During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by the Railway Administration if the CMP is found to be mentally or physically incapacitated. On joining of regular IRHS Doctors in the Central Hospital Jabalpur, the engagement shall be automatically terminated in the same fashion as would be decided by the administration.
- (iv) Engagement as CMP will not confer any right for automatic regularization, or absorption in the railway.
- (v) The CMP may avail free medical treatment for self only except operations categorized as 'special' in para 622(8) of IRMM 2000 and treatment normally available at super specialty centre in his/her respective zonal railway hospital during the currency of contract.
- (vi) The detailed instructions with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
- (vii) Appearance in the interview will not vest any right upon the candidate to be engaged as CMP and no reason(s) will be cited or communication shall be made with the candidate in the event of candidate not getting selected.
- (viii) The applicants may indicate their preference of posting in the Application Form however, this is not binding on the administration and they are liable to be posted as per administrative requirement.

**4. Facilities**

- (i) One Set First Class/AC-II complimentary PASS valid all over Indian Railway & Konkan Railway for self +spouse and dependent children (as per rule applicable to railway employees) in each contract after rendering three months of contracted service regularly.

**Note:-** No Railway Privilege Passes/PTO shall be admissible to retired Railway doctors engaged as CMPs in his/ her capacity of Contract Medical Practitioner.

**Terms and conditions for entering into contract with Medical Practitioners  
(Other than Retired Doctor) on full time basis.**

1. The contract shall be entered into for one year or less from the date of entering into contract. Period of Contract is not extendable on any grounds. However, the Railway administration shall reserve the right to enter into fresh contract with the Practitioner for another term.
2. The full time Contract Medical Practitioner (hereinafter referred to as CMP) who enters into contract with the Railways will not have any claim or right for his/ her continuity in service or automatic extension of the terms of contract.
3. During the validity of the contract, the CMP will be eligible to terminate the contract for betterment of his/her carrier or on any other grounds by giving 15 days notice to the Railways. The Railways can also terminate the contract at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. Contract shall also be terminated if the CMP is found to be mentally or physically incapacitated.
4. The CMP shall undergo a medical examination, before the contract is entered into for his/her fitness to perform the work awarded to him/her. At the time of entering into contract, the CMP shall produce certificates of his/her antecedents from two Gazetted Officers of the central/State Govt.
5. At the time of entering into contract, the CMP shall produce certificates for proof of date of birth, Caste and Educational Qualification.
6. The CMP shall have to undergo a brief orientation for a period of two week.
7. Normally Sundays and National Holidays will be off and authorized absence without affecting the fees shall be allowed at the rate of two days per month to be availed any time during the contract period to the extent earned up to that time. Any Medical Officer leaving his place of posting/availing/ National Holiday etc. should get prior permission from his Controlling Authority.
8. Expenses on outstation journeys connected with the contract with the contract works will be borne by the Railway. Duty Passes will be issued by the Railway for the purpose of journey in the line Jurisdiction of the Health Unit where the CMP renders service and to the Divisional Headquarters and the CMP will be paid a fixed rate of Daily allowance, i.e. Rs. 900/- (Rupees nine hundred only) per day during such journeys. This will be subjected to fulfillment of other provisions pertaining to Daily allowance prescribed in IREC Vol.-II. (Authority:- Board's letter No. 2014/E(GR)/II/1/1. Dated-19.12.2018).
9. The monthly fee for CMPs (subject to daily rate of proportionate reduction from the fee in the event of the CMP absents himself for period exceeding those stipulated in the contract) are at the following rates:-

10. (Authority:- Railway Board's Order No. 2017/Trans/01/ Policy/Health. Dated. 13.02.2018) the remuneration specified as above includes HRA and Transport Allowance in case of full time contract Doctors. All other terms and condition as laid down in Railway Board's letter No. 96/E (GR) 9/16 dated 23.02.2009 and as amended from time to time shall remain unchanged.
11. Full time CMP may be provided unfurnished accommodation subject to availability. In case Railway accommodation is provided to the CMP, an amount equivalent to HRA and licence fee of the accommodation so provided shall be deducted from the monthly fee admissible to the CMP.
12. Electric charge and water are to be recovered from the monthly fee.  
Authority:- Railway Board's Order No. 90/E(GR)/II/9/27 dated 02-01-1992.
13. The CMP may be issued 1<sup>st</sup> Class Green Duty Pass for self on administrative exigency. Authority:- Railway Board's Order No. 91/E(GR)/II/9/2 dated 30-07-1991.)
14. The CMP may avail of free medical treatment for self only except the operations categorized as "Special" in Para 622(8) of Indian Railway Medical Manual 2000 and treatment normally available at super specialty Centre from his/her respective Zonal Railway Hospital during the currency of contract. (Rly Board order no.96/E(GR)/II/9/16 Dated.23.02.2000)
15. The CMP shall be governed in respect of matters not referred to in these terms and conditions by any orders/ amendments to the terms of contract issued by the Railways from time to time.
16. The CMP shall attend to all normal tasks, which any medical practitioner is conventionally doing. He/She will also attend to emergencies and accidents.
17. CMP shall issue sick/ fitness Certificate for a period upto 7 day's beyond which a regular Railway Medical Authority available at the nearest Hospital/Dispensary/ Health Unit should countersign the Certificate so issued by him/her.
18. The CMP shall not perform administrative work like pre-employment/periodical medical examinations, sanction of leave to Group-C and D staff and certification with respect to food items considered unfit for human consumption etc. However, the CMP shall be allowed to permit Group-C and D casual leave if sought for 3 days or less at a stretch.
19. The CMP shall not make medical recommendation of any kind referred to Para 559 to 564 of Indian Railway Medical Manual, 2000.
20. The CMP will not have any financial powers. However, he/she may operate the impress account in accordance with the guidelines contained in IRMM. However, an authorized Railway Medical Officer shall be countersigned the cash voucher in such cases. No Cash impress account shall be recouped unless an Indian Railway Medical Authority countersigns the proposals.
21. The CMP shall not initiate/review/accept the confidential reports of Group-C Railway employee. However, he/she on request prepares and presents the performance report of the staff.
22. The CMP shall not indent or indent or condemn/recommend for any tools and plants.
23. The CMP may be issued 1<sup>st</sup> Class Green Duty Pass for self on administrative exigency. (Railway Board's Order No.91-E(GR)/II/9/2 dated.30.07.1991)

## Annexure-B.

### Terms and conditions of the contract of Retired doctors engaged as Contract Medical Practitioners.

1. The contract shall be entered into for one year or less from the date of entering into contract. Period of Contract is not Extendable on any grounds. However, the Railway administration shall reserve the right to enter into fresh contract with the Practitioner for another term.
2. For Retd. Govt. (Railway/Central/State/PSU) doctors, age should not be with in 65 years. However, the number of annual terms for engagement of retired doctors as CMP's may be enhanced up to 07 consecutive terms on year to year basis by giving at least one week's break from the expiry of each term subject to maximum 67 years of age. Retired doctors who have already completed 07 terms of previous engagement as CMP (after their retirement/VR etc) in Indian railway are not entitled for such engagement.
3. The retired Railway doctor engaged as Contract Medical Practitioner shall I not have any claim or right for his/ her continuity in service or automatic extension of the terms of contract.
4. During the validity of the contract, the CMP will be eligible to terminate the contract for betterment of his/her carrier or on any other grounds by giving 15 days notice to the Railways. The Railways can also terminate the contract at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. Contract shall also be terminated if the CMP is found to be mentally or physically incapacitated.
5. The CMP shall undergo a medical examination, before the contract is entered into for his/her fitness to perform the work awarded to him/her.
6. At the time of entering into contract, the CMP shall produce certificates for proof of date of birth, Caste and Educational Qualification.
7. Normally Sundays and National Holidays will be off and authorized absence without affecting the fees shall be allowed at the rate of two days per month to be availed any time during the contract period to the extent earned up to that time. Any Medical Officer leaving his place of posting/availing/ National Holiday etc. should get prior permission from his Controlling Authority.
8. Expenses on outstation journeys connected with the contract with the contract works will be borne by the Railway. Duty Passes will be issued by the Railway for the purpose of journey into the line Jurisdiction of the Health Unit where the CMP renders service and to the Divisional Headquarters and the CMP will be paid a fixed rate of Daily allowance, i.e. Rs. 900/- (Rupees nine hundred only) per day during such journeys. This will be subjected to fulfillment of other provisions pertaining to Daily allowance prescribed in IREC Vol.- II. (Authority:- Board's letter No. 2014/E(GR)/II/1/1. Dated-19.12.2018).
9. In the event of unauthorized absence of Contract medical Practitioner from duty or absence from duty for a period exceeding the period exceeding the period stipulated in the contract, there shall be proportionate deduction from remuneration.
10. The retired Railway doctor engaged as CMP may be provided with Railway accommodation at places where ear-marked Railway accommodation for Railway doctors for Railway doctors is vacant/ available after meeting the residential requirement of the serving Railway officers. In case Railway accommodation is provided to the CMP, an amount equivalent to HRA payable to a fresh entrance Group-A Jr. Scale and license fee of the Railway accommodation so provided shall be deducted from the monthly remuneration payable to the CMP.
11. No Railway Privilege Passes/PTOs shall be admissible to the retired Railway doctors engaged as CMPs in his/her capacity of Contract Medical Practitioner.
12. The CMP shall be governed in respect of matters not referred to in these terms and conditions by any orders/ amendments to the terms of contract issued by the Railways from time to time.
13. The CMP shall attend to all normal tasks, which any medical practitioner is conventionally doing. He/ She will also attend to emergencies and accidents.
14. No Financial or Administrative powers shall be vested in retired Railway doctors engaged as CMPs.
15. The CMP shall not be entitled to any Provident fund, Pension, Gratuity, Non-Practicing Allowance, Medical facilities, Seniority, Promotion, etc., or any other benefits available to the regular Railway servants shall be admissible.
16. Only fixed consolidated remuneration of Rs 95,000/- shall be payable the retired Railway doctors engaged as CMP. No Dearness Allowance and any other Allowance which are admissible to retired Railway servants shall be admissible. Monthly remuneration of Retired Medical Officer (on contractual engagement) + Pension drawn by the retired doctor should not exceed the Last pay Drawn. Retired Medical Officers may engaged for five consecutive terms, not being ore than one year each on fresh by giving at least one week's break from the end fo the previous contract subject to the condition that, age should not be more than 65 years (Authority :- Railway Board's Order NO. 2013/ E(R)/II/1/5 dated 09.07.2018).
17. The retired Railway doctor engaged as CMP shall be on full time appointment of the Railways and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
18. The CMP shall not perform administrative work like pre-employment or periodical medical examinations, sanction of leave to Group-C and D staff and certification with respect to food items considered unfit for human consumption, etc. However, the CMP shall be allowed to permit Group-C and D casual leave if sought for 3 days or less at a stretch.
19. The CMP shall not make medical recommendation of any kind referred to Para 559 to 564 of Indian Railway Medical Manual, 2000.
20. The CMP will not have any financial powers. However, he/she may operate the impress account in accordance with the guidelines contained in IRMM. However, an authorized Railway Medical Officer shall be countersigned the cash voucher in such cases. No Cash impress account shall be recouped unless an Indian Railway Medical Authority countersigns the proposals.
21. The CMP shall not initiate/review/accept the confidential reports of Group-C Railway employee. However, he/she on request prepares and presents the performance report of the staff.
22. The CMP shall not indent or condemn/recommend for any tools and plants.

## ANNEXURE- C

Terms and condition for entering contract as Part Time Lady Doctor.

(Authority : Board's letter No 2000/H-1/12/27/Pt.1 dated 06.10.2000 & letter No.2017/ Trans Cell/Health .dated 13.02.18 and other related information issued time to time).

1. Part time Lady Doctor on part-time basis (referred to hereinafter as Part Time Lady Doctor) as are engaged on contract from time to time for a duration of Six hours/ four hours/two hours daily.
2. The contract shall be entered into for one year or less from the date of entering into the contract. Period of contract is not extendable on any grounds. However, the Railway administration shall reserve the right to enter into fresh contract with the practitioner including Dental surgeon/Lady doctor (by giving at least one week's break from the end of previous engagement) upto 12(twelve) consecutive term on year to year basis or till attending the age of 65 years whichever is earlier and each term of engagement shall not exceed more than one year. (Rly board o.o. 2018/trans cell/health/medical issues date 26.10.2018)
3. The Part time Lady Doctor who enters into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the terms of contract.
4. For hospitals/health units which do not have lady doctors, engagement of a lady Doctor on part time contract basis may be done on lines similar to engagement of part time Dental surgeons. (Rly board o.o 2018/trans cell/conclave/Health dt. 23.03.18)
5. During the validity of the contract, the Part-time CMP (Dental Surgeon/Lady doctor) will be eligible to terminate the contract for betterment of his/her carrier or any other grounds by giving 15 days notice without assigning any reasons whatsoever. Contract shall also be terminated if the CMP is found to be mentally or physically incapacitated.
6. At the time of entering into contract, the Part time Lady Doctor shall produce original certificates for proof of his date of birth, cast and educational qualification.
7. At the time of entering into contract, the Part time Lady Doctor shall produce certificates of his/her antecedents from two Gazetted Officers of the Central/State Government.
8. The Part time Lady Doctor shall have to undergo a brief orientation for a period of two weeks.
9. The Part time Lady Doctor shall be of good general health. Any Medical practitioner engaged as part time CMP shall cease to be on contract on his attaining the age of 65 yrs. **The Part Time Lady Doctor must have three years working experience or be a postgraduate.**
10. Part Time CMPs Normally Sundays and National Holidays will be off. (Railway Board O.O.2017/Trans/01/Policy/Health Dt.13.02.2018)
11. The monthly fee for Part Time Lady Doctor and the daily rate of proportionate reduction from the fee in the event the Part Time Lady Doctor absents himself/herself for periods exceeding those stipulated in the contract, are at the following rates:
  - (a) Monthly Fee

11. The Part Time Lady Doctor shall be governed in respect of matters not referred to in these terms and conditions by any orders/amendments to the terms contract issued by the Railway from time to time.
12. The Part Time Lady Doctor shall not exercise any financial powers including operation of Impret account in exigencies shall be done by the Railway Medical Officer of the nearest Health Unit/Dispensary/Hospital.
13. The Part Time Lady Doctor shall not initiate/review/accept the annual confidential reports of Group 'C' Railway employees. However, He/She shall, on request, prepare and present the performance report of staff.
14. The Part Time Lady Doctor shall not indent or condemn/recommend for condemnation any tools and plants.
15. Part Time Lady Doctor will be available in the Railway Unit during the contract hours daily and will attend to Railway beneficiaries only. During the prescribed hours of duty the Part Time Lady Doctor shall not attend to any private patient or shall leave the premises of the unit in which he is engaged, except with the permission of the Head of the Hospital/Unit.
16. Part Time Lady Doctor will be required to perform minimal restorative dentistry, periodontal treatment, extraction, endodontic treatment and any emergent treatment.
17. The Part Time Lady Doctor will not be entitled to any concession granted to Railway employees and their families in case of exceptionally emergency cases, if any, referred to Part Time Lady Doctor at his private clinic or he is being called to attend the cases at the Railway Clinic, he does so free of charge. No extra payment will be made to him for the services thus rendered.
18. He will entitled to get one set of ordinary first class complementary pass available for All Indian Railways per year for self and family after completion of one year term.
19. The Part Time Lady Doctor should work in the morning OPD hours preferably.
